

**AGREEMENT FOR WATER SERVICE FOR INITIAL USERS**

(hereinafter called the "Applicant") and the Marlboro Water Company, Inc., (hereinafter called the "Company")

The Applicant hereby applies for water service from the Company upon the following terms:

1. The Applicant will pay to the Company the sum of **\$1000.00** for the connection fee, which when accepted by the Company will constitute the installation fee for water service.
2. The established residence installation fee is **\$50.00** (of which **\$10.00** is a membership fee). The meter will be set on the Applicant's property at the closest point to the existing water line.
3. The renter will pay a fee of **\$150.00** (of which **\$10.00** is membership, **\$40.00** is hookup and **\$100.00** is deposit).
4. The Applicant will, when water becomes available, purchase from the Company and will pay monthly at rates which will be fixed by the Board of Directors.
5. Rates for standby fire protection shall be determined by the Board of Directors.
6. The Applicant will comply with and be bound by the provisions of the policy and/or amendments thereof the Company, and such rules and regulations as may, from time to time, be adopted by the Company. The Company may terminate service to any Applicant failing to pay a water bill when thirty (30) days past due or for violating a Company policy.
7. In consideration of water service to serve the premises of the Applicant, the Applicant agrees to pay for water service at a minimum monthly rate of **\$18.50** residential and **\$21.50** commercial, beginning on the date service becomes available. The Applicant understands the minimum payments are in effect the full time shown above. Each consecutive monthly payment shall be made promptly when due, but nothing herein contained shall be construed to relieve the member of the obligation to pay for such amount of water as may actually be consumed.
8. The Applicant agrees to permit the Company ingress and egress to above described lands to inspect system and to lay, maintain, repair, remove and disconnect a service line and meter, and read meters at a point on Applicant's property to be designated by the Company for each meter with right of ingress and egress for these purposes over Applicant's property.
9. The Applicant will install and maintain at his own expense a service line which shall begin at the water meter and extend to the dwelling or other portions of his premises.
10. The Applicant assumes responsibility for any damages to meter or metering equipment.
11. In the event the Applicant shall breach this contract by refusing or failing, without just cause, to connect his service line to the distribution system, as set forth above, the Applicant agrees to pay the Company a lump sum of Eight Hundred Dollars (**\$1000.00**) as liquidated damages. A failure to connect would cause serious and substantial damage to the Company, and it would be difficult, if not impossible, to prove the amount of such damages the parties hereto have computed, estimated and agreed upon in an attempt to make a reasonable forecast of probable actual loss because of the difficulty of estimating with exactness the resulting damages.
12. Applicants applying for installation of 1", 1 1/2 " and 2" meters will be subject to this contract and the installation fee will be negotiated between both parties.
